AVAILABILITY

Available in all territory served by the Cooperative, subject to the Cooperative's Service Rules and Regulations.

APPLICABILITY

Applicable to any residential consumer of the Cooperative. In general, individual motors served under this schedule shall not exceed twenty (20) horsepower.

TYPE OF SERVICE

Single-phase or multi-phase, 60 hertz, at available secondary voltages.

MONTHLY RATE

Service Access Fee:

Single-phase	\$32.00	per month
Multi-phase	\$55.00	per month

Energy Charges (June through August):

First 1,000 kWh	@	\$0.10875	per kWh
Over 1,000 kWh	@	\$0.10875	per kWh

Energy Charges (December through February):

First 1,000 kWh	@	\$0.10875	per kWh
Over 1,000 kWh	@	\$0.09875	per kWh

Energy Charges (All Other Months):

First 1,000 kWh	@	\$0.10875	per kWh
Over 1,000 kWh	@	\$0.08875	per kWh

MINIMUM MONTHLY CHARGES

The minimum monthly charge under the above rate shall be no less than the sum of the service access fee and the excess service access fee.

MONTHLY EXCESS SERVICE ACCESS FEE

For consumers requiring more than 50 kVa of transformer capacity, the monthly excess service access fee shall be \$0.50 for each additional kVa or fraction thereof required.

TERMS OF PAYMENT

The above rates are net. In the event the current monthly bill is not paid within seventeen

(17) days from the date of the bill, the gross rates, which include a collection charge of five (5) percent on all net billing, shall apply. When the 17th day falls on Saturday, Sunday or a legal holiday, the first business day thereafter shall be added to the seventeen-day net payment period.

CONDITION OF SERVICE

All wiring, poles, lines, and other electrical equipment beyond the metering point, shall be considered the distribution system of the consumer and shall be furnished and maintained by the consumer.

INTERPRETATION OF SCHEDULE

The interpretation of, or the application by the Cooperative, or by any consumer, shall be subject to the Cooperative's Service Rules and Regulations.

POWER COST ADJUSTMENT (PCA) CLAUSE

The Energy Charge will be adjusted by the Power Cost Tracker as listed in Appendix "C" in effect and approved by the Cooperative's Board of Directors.
