MY SOLAR PROGRAM Purchase Tariff

Availability:

This tariff is available to members of Southeastern Indiana Rural Electric Membership Corporation (referenced as REMC in this rate tariff) that are located within the assigned service territory and take metered electrical service from the REMC. This tariff and terms and conditions set herein are available for and applicable to members' assigned shares of electrical energy produced by solar panels owned by Hoosier Energy and a participating resource of the My Solar program.

This tariff is only available to members who have applied for and been approved to participate in the My Solar Program ("Program"), and if applicable, have made the Upfront Payment. Members may participate in the Program in one of two ways:

Option 1: Member makes no Upfront Payment.

Option 2: Member makes a one-time Upfront Payment of \$500 per panel, where such

Payment may be revised from time-to-time by the REMC Board of Directors.

Effective Date:

This Tariff shall become effective on <u>August 1, 2018</u> and shall remain in effect until revised, amended, or otherwise changed by the Southeastern Indiana REMC Board of Directors.

Monthly Rate:

Option 1: Member will pay the REMC 1.0 cents per kWh for all kWhs assigned to the

Member in accordance with the provisions of Energy Metering and Assignment

described below.

Option 2: REMC will pay the Member 5.5 cents per kWh for all kWhs assigned to the

Member in accordance with the provisions of Energy Metering and Assignment

described below.

Payments:

Any payments due Member pursuant to this tariff shall be netted against Member's periodic bill for electric service (kWhs) pursuant to the applicable REMC rate tariff.

ENERGY METERING AND ASSIGNMENT:

In exchange for participation in the Program, each month Member shall be assigned the electric energy produced by one (1) solar panel, with an approximate rating of 330 W ac, from community solar energy resources owned and operated by Hoosier Energy ("Assigned Energy"). Member may elect to participate in the program for a maximum of 12 panels.

At the conclusion of each month, Hoosier Energy will determine from meter readings, the total energy produced by the participating community solar energy resources and shall equitably assign to each participating member proportional amounts of energy. Such proportional amounts shall be determined as the member's number of panels divided by the total number of panels. The member's Assigned Energy shall be determined by multiplying the total monthly energy production times the member's proportional amount.

Terms and Conditions:

This Tariff shall supersede and replace any previous My Solar Program Purchase Tariff used or promulgated by REMC.

This tariff shall not be subject to the "Purchased Power Cost Adjustment Tracking Factor" pursuant to retail rate tariffs Appendix "C".

Under no circumstances will the member have any ownership interest in any of the participating production resources of the My Solar program.

The Assigned Energy amounts will not reduce the quantities of energy and demand metered and billed under the applicable REMC rate tariff.

Interpretation of Schedule:

The interpretation of, or application by the REMC, or by any Member (Seller), shall be subject to the REMC's "Service Rules and Regulations".
